BACKGROUND

Olfactory receptors are G protein-coupled receptors that localize to the cilia of olfactory sensory neurons where they display affinity for and bind to a variety of odor molecules. The genes encoding olfactory receptors comprise the largest family in the human genome. The binding of olfactory receptor proteins to odor molecules triggers a signal transduction that propagates nerve impulses throughout the body, ultimately leading to transmission of the signal to the brain and the subsequent perception of smell. OR10Z1 (olfactory receptor 10Z1), also known as olfactory receptor OR1-15, is a 313 amino acid multi-pass membrane protein and odorant receptor belonging to the G-protein coupled receptor 1 family. The gene encoding OR10Z1 maps to human chromosome 1q23.1.

CHROMOSOMAL LOCATION

Genetic locus: OR10Z1 (human) mapping to 1q23.1.

SOURCE

OR10Z1 (S-12) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an extracellular domain of OR10Z1 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-104505 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

STORAGE

Store at 4° C, **D0 NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

APPLICATIONS

OR10Z1 (S-12) is recommended for detection of OR10Z1 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other OR10 family members .

OR10Z1 (S-12) is also recommended for detection of OR10Z1 in additional species, including canine.

Suitable for use as control antibody for OR10Z1 siRNA (h): sc-78875, OR10Z1 shRNA Plasmid (h): sc-78875-SH and OR10Z1 shRNA (h) Lentiviral Particles: sc-78875-V.

Molecular Weight of OR10Z1: 35 kDa.
