FBXO17/27 (V-14): sc-109470



The Power to Question

BACKGROUND

F-box (FBX) proteins are critical components of the SCF (Skp1-CUL-1-F-box protein) type E3 ubiquitin ligase complex and are involved in substrate recognition and recruitment for ubiquitination. FBXs are members of a larger family of proteins that are involved in the regulation of a wide variety of cellular processes (including the cell cycle, immune responses, signaling cascades and developmental events) through the targeting of proteins, such as cyclins, cyclindependent kinase inhibitors, $l\kappa B$ - α and β -catenin, for proteasomal degradation. FBX017 (F-box only protein 17), also known as FBG4, FBX17, FBX26 or FBX026, is a 278 amino acid protein that contains one F-box domain and one F-box associated domain. Expressed in kidney, heart, liver, skeletal muscle, brain and spleen, FBX017 functions as a substrate-recognition component of of the SCF complex and directly interacts with Skp1 p19 and CUL-1. Multiple isoforms of FBX017 exist due to alternative splicing events.

Genetic locus: FBXO17/FBXO27 (human) mapping to 19q13.2; Fbxo17/Fbxo27 (mouse) mapping to 7 A3.

SOURCE

FBX017/27 (V-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of FBX017 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-109470 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FBX017/27 (V-14) is recommended for detection of FBX017 and FBX027 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

FBX017/27 (V-14) is also recommended for detection of FBX017 and FBX027 in additional species, including equine, canine, bovine and porcine.

Molecular Weight of FBX017/27: 31 kDa.

RECOMMENDED SECONDARY REAGENTS

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) or donkey anti-goat IgG-TR: sc-2783 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.
