ROG (S-17): sc-11247



BACKGROUND

GATA-3, a T-cell specific zinc-finger transcription factor, is essential for the development, differentiation, and activation of T helper (Th) cells, which are capable of secreting high levels of cytokines. The GATA-3 interacting protein, ROG (repressor of GATA), also known as TZFP, represses the function of GATA-3 in part by preventing the binding of GATA-3 to its cognate DNA target se-quence. Overexpression of ROG in Th cells specifically inhibits the production of cytokines Th1 and Th2, suggesting that ROG may regulate the differentiation of Th cells. Direct binding of ROG to DNA suggests that ROG is a potent negative regulator of Th cytokine genes as well as noncytokines genes. ROG is a lymphoid specific, member of the POZ protein family that is expressed at very low levels in resting T-cells. Expression of ROG is substatially higher in both resting and activated B cells.

SOURCE

ROG (S-17) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of ROG of mouse origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-11247 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

ROG (S-17) is recommended for detection of ROG of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

ROG (S-17) is also recommended for detection of ROG in additional species, including equine, canine, bovine and porcine.

Suitable for use as control antibody for ROG siRNA (h): sc-38355, ROG siRNA (m): sc-38356, ROG shRNA Plasmid (h): sc-38355-SH, ROG shRNA Plasmid (m): sc-38356-SH, ROG shRNA (h) Lentiviral Particles: sc-38355-V and ROG shRNA (m) Lentiviral Particles: sc-38356-V.
