The Power to Question

BACKGROUND

A variety of growth factor signaling molecules have been shown to regulate $\mathcal{C}.$ elegans development, including members of the EGF, FGF and TGF superfamilies. These factors bind to specific receptors and transduce extracellular signals to the nucleus. Receptor tyrosine kinase/Ras pathways also play a critical role in cell signaling and are responsible for proper vulval development. In vertebrate visual and olfactory systems, a cyclic nucleotide-gated channel couples receptor activation to electrical activity of the sensory neurons. TAX-4 and TAX-2 are essential for normal olfaction, gustation, chemosensation, thermosensation, normal axon outgrowth of some sensory neurons and may have a role in sensory transduction. TAX-4 and TAX-2 are similar to the cyclic nucleotide-gated channel subunits used in vertebrate vision and olfaction. TAX-4 is highly related to the α subunits, while TAX-2 is most closely related to the beta subunits of the rod phototransduction channels.

SOURCE

TAX-4 (cN-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of TAX-4 of $\it C. elegans$ origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-12225 P, (100 μg peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

TAX-4 (cN-20) is recommended for detection of TAX-4 of *Caenorhabditis elegans* origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

RECOMMENDED SECONDARY REAGENTS

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) or donkey anti-goat IgG-TR: sc-2783 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.
