# TOX4 (N-16): sc-132124



The Power to Question

# **BACKGROUND**

TOX high mobility group box family member 4 (TOX4), also known as epidermal Langerhans cell protein 1 (LCP1), is a 621 amino acid protein that localizes to the nucleus. Mapping to chromosome 14q11.2, TOX4 contains one high mobility group (HMG) box DNA-binding domain, corresponding to amino acids 223 to 291 of human TOX4. The HMG box domain is a region of about 80 amino acids with unusual DNA-binding preferences. HMG proteins bind DNA without sequence specificity. Furthermore, they bind to distorted or modified DNA and have the property to bend DNA. The presence of the HMG box DNA-binding domain suggests that TOX4 plays a role in transcriptional regulation.

# CHROMOSOMAL LOCATION

Genetic locus: TOX4 (human) mapping to 14q11.2; Tox4 (mouse) mapping to 14 C2.

# **SOURCE**

TOX4 (N-16) is an affinity purified goat polyclonal antibody raised against a peptide mapping at the N-terminus of TOX4 of human origin.

#### **PRODUCT**

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-132124 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

Available as TransCruz reagent for Gel Supershift and ChIP applications, sc-132124 X, 200  $\mu$ g/0.1 ml.

# **APPLICATIONS**

TOX4 (N-16) is recommended for detection of TOX4 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with family member TOX3.

TOX4 (N-16) is also recommended for detection of TOX4 in additional species, including equine, canine, bovine and porcine.

Suitable for use as control antibody for TOX4 siRNA (h): sc-92350, TOX4 siRNA (m): sc-154564, TOX4 shRNA Plasmid (h): sc-92350-SH, TOX4 shRNA Plasmid (m): sc-154564-SH, TOX4 shRNA (h) Lentiviral Particles: sc-92350-V and TOX4 shRNA (m) Lentiviral Particles: sc-154564-V.

TOX4 (N-16) X TransCruz antibody is recommended for Gel Supershift and ChIP applications.
