FAM55D (G-12): sc-132682



The Power to Question

BACKGROUND

FAM55D (family with sequence similarity 55, member D), also known as C11orf33, is a 544 amino acid secreted protein that is expressed as two isoforms due to alternative splicing events. The gene encoding FAM55D is located on chromosome 11. With approximately 135 million base pairs and 1,400 genes, chromosome 11 makes up around 4% of human genomic DNA and is considered a gene and disease association dense chromosome. The chromosome 11 encoded ATM gene is important for regulation of cell cycle arrest and apoptosis following double strand DNA breaks. ATM mutation leads to the disorder known as ataxia-telangiectasia. The blood disorders Sickle cell anemia and thalassemia are caused by HBB gene mutations. Wilms' tumors, WAGR syndrome and Denys-Drash syndrome are associated with mutations of the WT1 gene. Jervell and Lange-Nielsen syndrome, Jacobsen syndrome, Niemann-Pick disease, hereditary angioedema and Smith-Lemli-Opitz syndrome are also associated with defects in chromosome 11.

Genetic locus: Fam55d (mouse) mapping to 9 A5.3.

SOURCE

FAM55D (G-12) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of FAM55D of mouse origin.

STORAGE

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-132682 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FAM55D (G-12) is recommended for detection of FAM55D isoforms 1 and 2 of mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with family members FAM55A, FAM55B or FAM55C.

Suitable for use as control antibody for FAM55D siRNA (m): sc-142861, FAM55D shRNA Plasmid (m): sc-142861-SH and FAM55D shRNA (m) Lentiviral Particles: sc-142861-V.

Molecular Weight of FAM55D: 62 kDa.
