ZNF296 (G-13): sc-133053



BACKGROUND

Zinc-finger proteins contain DNA-binding domains and have a wide variety of functions, most of which encompass some form of transcriptional activation or repression. The majority of zinc-finger proteins contain a Krüppel-type DNA binding domain and a KRAB domain, which is thought to interact with KAP1, thereby recruiting histone modifying proteins. As a member of the Krüppel C_2H_2 -type zinc-finger protein family, ZNF342 (zinc finger protein 342), also known as Zinc finger protein 296, is a 475 amino acid nuclear protein that contains six C_2H_2 -type zinc fingers through which it is thought to be involved in DNA-binding and transcriptional regulation.

Genetic locus: ZNF296 (human) mapping to 19q13.32.

SOURCE

ZNF296 (G-13) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of ZNF296 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-133053 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

STORAGE

Store at 4° C, **D0 NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

APPLICATIONS

ZNF296 (G-13) is recommended for detection of ZNF296 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other ZNF family members.

Suitable for use as control antibody for ZNF296 siRNA (h): sc-97179, ZNF296 shRNA Plasmid (h): sc-97179-SH and ZNF296 shRNA (h) Lentiviral Particles: sc-97179-V.

Molecular Weight of ZNF296: 51 kDa.

Positive Controls: Jurkat whole cell lysate: sc-2204.
