BACKGROUND

CCDC138 (coiled-coil domain containing 138), also known as FLJ32745, is a 685 amino acid protein expressed as 2 isoforms produced by alternative splicing. The gene that encodes CCDC138 maps to human chromosome 2q12.3. The second largest human chromosome, chromosome 2 consists of 237 million bases, encodes over 1,400 genes and makes up approximately 8% of the human genome. A number of genetic diseases are linked to genes on chromosome 2. Harlequin icthyosis, a rare and morbid skin deformity, is associated with mutations in the ABCA12 gene. The lipid metabolic disorder sitosterolemia is associated with ABCG5 and ABCG8. An extremely rare recessive genetic disorder, Alström syndrome is due to mutations in the ALMS1 gene. Interestingly, chromosome 2 contains what appears to be a vestigial second centromere and vestigial telomeres which gives credence to the hypothesis that human chromosome 2 is the result of an ancient fusion of two ancestral chromosomes seen in modern form today in apes.

Genetic locus: CCDC138 (human) mapping to 2q12.3; Ccdc138 (mouse) mapping to 10 B4.

SOURCE

CCDC138 (S-13) is an affinity purified rabbit polyclonal antibody raised against a peptide mapping within an internal region of CCDC138 of human origin.

RESEARCH USE

For research use only, not for use in diagnostic procedures.

PRODUCT

Each vial contains 100 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-138184 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

CCDC138 (S-13) is recommended for detection of CCDC138 of mouse, rat and human origin by Western Blotting (starting dilution 1:100, dilution range 1:50-1:500), immunofluorescence (starting dilution 1:25, dilution range 1:25-1:250) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other CCDC family members.

Suitable for use as control antibody for CCDC138 siRNA (h): sc-94315, CCDC138 shRNA Plasmid (h): sc-94315-SH and CCDC138 shRNA (h) Lentiviral Particles: sc-94315-V.

Molecular Weight of CCDC138 isoforms: 76/66 kDa.
