EIG121L (K-15): sc-139511



The Power to Question

BACKGROUND

ElG121L, also known as hElG121L, is a 1,029 single-pass type I membrane protein that belongs to the UPF0577 familiy. ElG121L can be glycosylated at amino acid positions 169, 405 and 691. Due to alternate splicing events, ElG121L exists as two isoforms. The gene encoding ElG121L maps to human chromosome 7q21.12, which houses over 1,000 genes and comprises nearly 5% of the human genome. Chromosome 7 has been linked to osteogenesis imperfecta, Pendred syndrome, lissencephaly, citrullinemia and Shwachman-Diamond syndrome. The deletion of a portion of the q arm of chromosome 7 is associated with Williams-Beuren syndrome, a condition characterized by mild mental retardation, an unusual comfort and friendliness with strangers and an elfin appearance. Deletions of portions of the q arm of chromosome 7 are also seen in a number of myeloid disorders including cases of acute myelogenous leukemia and myelodysplasia.

Genetic locus: KIAA1324L (human) mapping to 7q21.12; 9330182L06Rik (mouse) mapping to 5 A1.

STORAGE

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

SOURCE

EIG121L (K-15) is an affinity purified rabbit polyclonal antibody raised against a peptide mapping within a C-terminal cytoplasmic domain of EIG121L of human origin.

PRODUCT

Each vial contains 100 μg IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-139511 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

EIG121L (K-15) is recommended for detection of EIG121L of human origin, 9330182L06Rik of mouse origin and the corresponding rat homolog by Western Blotting (starting dilution 1:100, dilution range 1:50-1:500), immunofluorescence (starting dilution 1:25, dilution range 1:25-1:250) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with EIG121 or 5330417C22Rik.

EIG121L (K-15) is also recommended for detection of EIG121L in additional species, including equine, canine, bovine, porcine and avian.

Suitable for use as control antibody for EIG121L siRNA (h): sc-89404, 9330182L06Rik siRNA (m): sc-140547, EIG121L shRNA Plasmid (h): sc-89404-SH, 9330182L06Rik shRNA Plasmid (m): sc-140547-SH, EIG121L shRNA (h) Lentiviral Particles: sc-89404-V and 9330182L06Rik shRNA (m) Lentiviral Particles: sc-140547-V.
