C15orf41 (C-14): sc-163818



The Boures to Overtion

BACKGROUND

Encoding more than 700 genes, chromosome 15 is made up of approximately 106 million base pairs and is about 3% of the human genome. Angelman and Prader-Willi syndromes are associated with loss of function or deletion of genes in the 15q11-q13 region. In the case of Angelman syndrome, this loss is due to inactivity of the maternal 15q11-q13-encoded UBE3A gene in the brain by either chromosomal deletion or mutation. In cases of Prader-Willi syndrome, there is a partial or complete deletion of this region from the paternal copy of chromosome 15. Tay-Sachs disease is a lethal disorder associated with mutations of the HEXA gene, which is encoded by chromosome 15. Marfan syndrome is associated with chromosome 15 through the FBN1 gene. The C15orf41 gene product has been provisionally designated C15orf41 pending further characterization.

CHROMOSOMAL LOCATION

Genetic locus: C15orf41 (human) mapping to 15q14; BC052040 (mouse) mapping to 2 E4.

SOURCE

C15orf41 (C-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of C15orf41 of human origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-163818 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

C15orf41 (C-14) is recommended for detection of C15orf41 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other C15orf family members.

C15orf41 (C-14) is also recommended for detection of C15orf41 in additional species, including equine, canine, bovine, porcine and avian.

Suitable for use as control antibody for C15orf41 siRNA (h): sc-90179, C15orf41 siRNA (m): sc-141835, C15orf41 shRNA Plasmid (h): sc-90179-SH, C15orf41 shRNA Plasmid (m): sc-141835-SH, C15orf41 shRNA (h) Lentiviral Particles: sc-90179-V and C15orf41 shRNA (m) Lentiviral Particles: sc-141835-V.
