# CEP27 (E-14): sc-164045



The Power to Question

## BACKGROUND

Centrosomes are the major microtubule-organizing centers of mammalian cells. They are composed of a centriole pair and surrounding microtubulenucleating material termed pericentriolar material (PCM). Bipolar mitotic spindle assembly relies on two intertwined processes: centriole duplication and centrosome maturation. Failure to properly orchestrate centrosome duplication and maturation is subsequently linked to spindle defects, which can result in aneuploidy and promote cancer progression. CEP27 (centrosomal protein of 27 kDa), also known as HAUS2 (HAUS augmin-like complex subunit 2), is a 235 amino acid protein that localizes to interphase centrosomes and mitotic spindle microtubules. As one of eight components of the HAUS augmin-like complex, CEP27 also contributes to regulation of mitotis spindle assembly and centrosomal integrity. There are two isoforms of CEP27 that are produced as a result of alternative splicing events.

Genetic locus: HAUS2 (human) mapping to 15q15.2.

## SOURCE

CEP27 (E-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of CEP27 of human origin.

#### PRODUCT

Each vial contains 200  $\mu g$  IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-164045 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

## APPLICATIONS

CEP27 (E-14) is recommended for detection of CEP27 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other CEP family member.

Suitable for use as control antibody for CEP27 siRNA (h): sc-89993, CEP27 shRNA Plasmid (h): sc-89993-SH and CEP27 shRNA (h) Lentiviral Particles: sc-89993-V.

Molecular Weight of CEP27: 27/17 kDa.
