# TMEM62 (T-14): sc-165747



## BACKGROUND

TMEM62 (transmembrane protein 62) is a 643 amino acid protein encoded by a gene mapping to human chromosome 15. Encoding more than 700 genes, chromosome 15 is made up of approximately 106 million base pairs and is about 3% of the human genome. Angelman and Prader-Willi syndromes are associated with loss of function or deletion of genes in the 15q11-q13 region. In the case of Angelman syndrome, this loss is due to inactivity of the maternal 15q11-q13-encoded UBE3A gene in the brain by either chromosomal deletion or mutation. In cases of Prader-Willi syndrome, there is a partial or complete deletion of this region from the paternal copy of chromosome 15. Tay-Sachs disease is a lethal disorder associated with mutations of the HEXA gene, which is encoded by chromosome 15. Marfan syndrome is associated with chromosome 15 through the FBN1 gene.

Genetic locus: TMEM62 (human) mapping to 15q15.2; Tmem62 (mouse) mapping to 2 E5.

### SOURCE

TMEM62 (T-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of TMEM62 of human origin.

## PRODUCT

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-165747 P, (100  $\mu g$  peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

## **APPLICATIONS**

TMEM62 (T-14) is recommended for detection of TMEM62 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other TMEM family members.

TMEM62 (T-14) is also recommended for detection of TMEM62 in additional species, including equine and canine.

Suitable for use as control antibody for TMEM62 siRNA (h): sc-90155, TMEM62 siRNA (m): sc-154486, TMEM62 shRNA Plasmid (h): sc-90155-SH, TMEM62 shRNA Plasmid (m): sc-154486-SH, TMEM62 shRNA (h) Lentiviral Particles: sc-90155-V and TMEM62 shRNA (m) Lentiviral Particles: sc-154486-V.
