EID-3 (P-14): sc-167738



The Power to Question

BACKGROUND

EID-3 (EP300-interacting inhibitor of differentiation 3), also known as E1A-like inhibitor of differentiation 3, is a 333 amino acid protein belonging to the NSE4 family. Localizing to nucleus and cytoplasm, EID-3 is highly expressed in testis. EID-3 may interfere with CBP-dependent coactivation by acting as a repressor of nuclear receptor-dependent transcription, and may act as a coinhibitor to other CBP/p300 dependent transcription factors. EID-3 exists as a homodimer or heterodimer with EID-2, and is encoded by a gene that maps to human chromosome 12q23.3. Encoding over 1,100 genes within 132 million bases, chromosome 12 makes up about 4.5% of the human genome. A number of skeletal deformities are linked to chromosome 12 including hypochondrogenesis, achondrogenesis and Kniest dysplasia.

Genetic locus: Eid3 (mouse) mapping to 10 C1.

SOURCE

EID-3 (P-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of EID-3 of mouse origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-167738 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

EID-3 (P-14) is recommended for detection of EID-3 of mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other EID family members.

Suitable for use as control antibody for EID-3 siRNA (m): sc-144608, EID-3 shRNA Plasmid (m): sc-144608-SH and EID-3 shRNA (m) Lentiviral Particles: sc-144608-V.

Molecular Weight of EID-3: 38 kDa.
