# NBEAL1 (N-14): sc-168718



The Power to Question

#### **BACKGROUND**

NBEAL1 (neurobeachin-like 1), also known as ALS2CR16 (amyotrophic lateral sclerosis 2 chromosomal region candidate gene 16 protein) or ALS2CR17, is a 2,694 amino acid protein that belongs to the WD repeat Neurobeachin family. While highly expressed in kidney, brain, prostate and testis, NBEAL1 is also found at low levels in peripheral blood leukocytes, small intestine, ovary and colon. NBEAL1 contains one BEACH domain and two WD repeats, and undergoes alternative splicing to produce two isoforms. The gene encoding NBEAL1 maps to human chromosome 2, which consists of 237 million bases, encodes over 1,400 genes and makes up approximately 8% of the human genome. A number of genetic diseases are linked to genes on chromosome 2 including Harlequin icthyosis, sitosterolemia and Alström syndrome.

#### CHROMOSOMAL LOCATION

Genetic locus: NBEAL1 (human) mapping to 2q33.2; Nbeal1 (mouse) mapping to 1 C2.

#### **SOURCE**

NBEAL1 (N-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of NBEAL1 of human origin.

# **PRODUCT**

Each vial contains 200  $\mu g$  IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-168718 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

#### **APPLICATIONS**

NBEAL1 (N-14) is recommended for detection of NBEAL1 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with NBEAL2.

NBEAL1 (N-14) is also recommended for detection of NBEAL1 in additional species, including equine and canine.

Suitable for use as control antibody for NBEAL1 siRNA (h): sc-94256, NBEAL1 siRNA (m): sc-149846, NBEAL1 shRNA Plasmid (h): sc-94256-SH, NBEAL1 shRNA Plasmid (m): sc-149846-SH, NBEAL1 shRNA (h) Lentiviral Particles: sc-94256-V and NBEAL1 shRNA (m) Lentiviral Particles: sc-149846-V.
