PRRT1 (G-15): sc-169052



The Power to Question

BACKGROUND

Making up nearly 6% of the human genome, chromosome 6 contains around 1,200 genes within 170 million base pairs of sequence. Deletion of a portion of the q arm of chromosome 6 is associated with early onset intestinal cancer suggesting the presence of a cancer susceptibility locus. Porphyria cutanea tarda is associated with chromosome 6 through the HFE gene which, when mutated, predisposes an individual to developing this porphyria. Notably, the PARK2 gene, which is associated with Parkinson's disease, and the genes encoding the major histocompatibility complex proteins, which are key molecular components of the immune system and determine predisposition to rheumatic diseases, are also located on chromosome 6. Stickler syndrome, 21-hydroxylase deficiency and maple syrup urine disease are also associated with genes on chromosome 6. A bipolar disorder susceptibility locus has been identified on the q arm of chromosome 6. The PRRT1 gene product has been provisionally designated PRRT1 pending further characterization.

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

CHROMOSOMAL LOCATION

Genetic locus: PRRT1 (human) mapping to 6p21.32; Prrt1 (mouse) mapping to 17 B1.

SOURCE

PRRT1 (G-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of PRRT1 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-169052 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

PRRT1 (G-15) is recommended for detection of PRRT1 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with PRRT2 or PRRT3.

Suitable for use as control antibody for PRRT1 siRNA (h): sc-95074, PRRT1 siRNA (m): sc-152520, PRRT1 shRNA Plasmid (h): sc-95074-SH, PRRT1 shRNA Plasmid (m): sc-152520-SH, PRRT1 shRNA (h) Lentiviral Particles: sc-95074-V and PRRT1 shRNA (m) Lentiviral Particles: sc-152520-V.
