TMPRSS11B (E-13): sc-169633



The Power to Question

BACKGROUND

TMPRSS11B (transmembrane protease serine 11B), also known as airway trypsin-like protease 5, is a 416 amino acid single-pass type II membrane protein that belongs to the peptidase S1 family and contains one peptidase S1 domain and one SEA domain. The gene that encodes TMPRSS11B consists of over 19,000 bases and maps to human chromosome 4q13.2. Chromosome 4 represents approximately 6% of the human genome and contains nearly 900 genes. Notably, the Huntingtin gene, which is found to encode an expanded glutamine tract in cases of Huntington's disease, is encoded by a gene that maps to chromosome 4. FGFR-3 is also encoded by a gene located on chromosome 4 and has been associated with thanatophoric dwarfism, achondroplasia, Muenke syndrome and bladder cancer. Chromosome 4 is also tied to Ellis-van Creveld syndrome, methylmalonic acidemia and polycystic kidney disease.

Genetic locus: Tmprss11bnl (mouse) mapping to 5 E1.

SOURCE

TMPRSS11B (E-13) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an N-terminal extracellular domain of TMPRSS11B of mouse origin.

RESEARCH USE

For research use only, not for use in diagnostic procedures.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-169633 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

TMPRSS11B (E-13) is recommended for detection of TMPRSS11B of mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other TMPRSS11 family members .

Suitable for use as control antibody for TMPRSS11B siRNA (m): sc-154521, TMPRSS11B shRNA Plasmid (m): sc-154521-SH and TMPRSS11B shRNA (m) Lentiviral Particles: sc-154521-V.

Molecular Weight of TMPRSS11B: 46 kDa.
