Miner2 (C-14): sc-241558



The Power to Question

BACKGROUND

Miner2 (mitoNEET-related protein 2), also known as CISD3 (CDGSH iron-sulfur domain-containing protein 3, mitochondrial), is a 127 amino acid mitochondrial protein that belongs to the CISD protein family. Miner2 binds two iron-sulfur clusters per subunit and is encoded by a gene that maps to human chromosome 17q12. Chromosome 17 comprises over 2.5% of the human genome and encodes over 1,200 genes. Two key tumor suppressor genes are associated with chromosome 17, namely, p53 and BRCA1. Malfunction or loss of p53 expression is associated with malignant cell growth and Li-Fraumeni syndrome. Like p53, BRCA1 is directly involved in DNA repair, and is linked to predisposition of cancers of the ovary, colon, prostate gland and fallopian tubes.

CHROMOSOMAL LOCATION

Genetic locus: CISD3 (human) mapping to 17q12; Cisd3 (mouse) mapping to 11 D.

SOURCE

Miner2 (C-14) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of Miner2 of human origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-241558 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

Miner2 (C-14) is recommended for detection of Miner2 of mouse and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with ERIS or mitoNEET.

Miner2 (C-14) is also recommended for detection of Miner2 in additional species, including equine, canine, bovine and porcine.

Molecular Weight of Miner2: 14 kDa.

RECOMMENDED SECONDARY REAGENTS

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) or donkey anti-goat IgG-TR: sc-2783 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.
