SPINT4 (T-12): sc-241685



The Power to Question

BACKGROUND

SPINT4 (serine peptidase inhibitor, kunitz type 4), also known as SPINT3 or kunitz-type protease inhibitor 4, is a 99 amino acid secreted protein that contains one BPTI/kunitz inhibitor domain. The gene encoding SPINT4 maps to human chromosome 20q13.12. Comprising approximately 2% of the human genome, chromosome 20 contains nearly 63 million bases that encode over 600 genes, some of which are associated with Creutzfeldt-Jakob disease, amyotrophic lateral sclerosis, spinal muscular atrophy, ring chromosome 20 epilepsy syndrome and Alagille syndrome. Additionally, chromosome 20 contains a region with numerous genes which are thought important for seminal production and may be potential targets for male contraception.

CHROMOSOMAL LOCATION

Genetic locus: Spint4 (mouse) mapping to 2 H3.

SOURCE

SPINT4 (T-12) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of SPINT4 of mouse origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-241685 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

SPINT4 (T-12) is recommended for detection of SPINT4 of mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with HAI-1 or HAI-2.

Suitable for use as control antibody for SPINT4 siRNA (m): sc-153770, SPINT4 shRNA Plasmid (m): sc-153770-SH and SPINT4 shRNA (m) Lentiviral Particles: sc-153770-V.

Molecular Weight of SPINT4: 11 kDa.
