FDXACB1 (C-15): sc-242811



The Power to Question

BACKGROUND

FDXACB1 is a 624 amino acid protein encoded by a gene that maps to human chromosome 11, which makes up around 4% of human genomic DNA and is considered a gene and disease association dense chromosome. The chromosome 11 encoded Atm gene is important for regulation of cell cycle arrest and apoptosis following double strand DNA breaks. Atm mutation leads to the disorder known as ataxia-telangiectasia. The blood disorders Sickle cell anemia and β thalassemia are caused by HBB gene mutations. Wilms' tumors, WAGR syndrome and Denys-Drash syndrome are associated with mutations of the WT1 gene. Jervell and Lange-Nielsen syndrome, Jacobsen syndrome, Niemann-Pick disease, hereditary angioedema and Smith-Lemli-Opitz syndrome are also associated with defects in chromosome 11.

Genetic locus: FDXACB1 (human) mapping to 11q23.1; Fdxacb1 (mouse) mapping to 9 A5.3.

SOURCE

FDXACB1 (C-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of FDXACB1 of human origin.

RESEARCH USE

For research use only, not for use in diagnostic procedures.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-242811 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FDXACB1 (C-15) is recommended for detection of FDXACB1 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

FDXACB1 (C-15) is also recommended for detection of FDXACB1 in additional species, including equine, canine and porcine.

Suitable for use as control antibody for FDXACB1 siRNA (m): sc-142835, FDXACB1 shRNA Plasmid (m): sc-142835-SH and FDXACB1 shRNA (m) Lentiviral Particles: sc-142835-V.
