The Power to Question

BACKGROUND

KIAA0947 is a 2,266 amino acid protein that contains one coiled coil domain and is post-translationally phosphorylated at several serine residues. KIAA0947 also undergoes one phophorylation event at threonine residue 1675 and may become acetylated at lysine 1218. The gene encoding KIAA0947 maps to human chromosome 5, which contains 181 million base pairs and comprises nearly 6% of the human genome. Chromosome 5 is associated with Cockayne syndrome through the ERCC8 gene and familial adenomatous polyposis through the adenomatous polyposis *coli* (APC) tumor suppressor gene. Treacher Collins syndrome is also chromosome 5-associated and is caused by insertions or deletions within the TCOF1 gene. Deletion of the p arm of chromosome 5 leads to Cri du chat syndrome, while deletion of the q arm or of chromosome 5 altogether is common in therapy-related acute myelogenous leukemias and myelodysplastic syndrome.

Genetic locus: KIAA0947 (human) mapping to 5p15.32.

SOURCE

KIAA0947 (E-17) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of KIAA0947 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-243173 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

KIAA0947 (E-17) is recommended for detection of KIAA0947 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

KIAA0947 (E-17) is also recommended for detection of KIAA0947 in additional species, including equine and canine.
