LEP503 (G-15): sc-243250



The Power to Question

BACKGROUND

LEP503 (lens epithelial cell protein LEP503) is a 61 amino acid protein that is expressed in epithelial cells, where it may play a role in epithelial cell differentiation. The gene encoding LEP503 maps to human chromosome 1q21.3. Chromosome 1 spans 260 million base pairs, contains over 3,000 genes and comprises nearly 8% of the human genome. Chromosome 1 houses a large number of disease-associated genes, including those that are involved in familial adenomatous polyposis, Stickler syndrome, Parkinson's disease, Gaucher disease, schizophrenia and Usher syndrome. Aberrations in chromosome 1 are found in a variety of cancers, including head and neck cancer, malignant melanoma and multiple myeloma.

Genetic locus: LENEP (human) mapping to 1g21.3.

SOURCE

LEP503 (G-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of LEP503 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-243250 P, ($100 \mu g$ peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

LEP503 (G-15) is recommended for detection of LEP503 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Suitable for use as control antibody for LEP503 siRNA (h): sc-78798, LEP503 shRNA Plasmid (h): sc-78798-SH and LEP503 shRNA (h) Lentiviral Particles: sc-78798-V.

Molecular Weight of LEP503: 7 kDa.
