LRRC20 (S-15): sc-243337



The Power to Question

BACKGROUND

LRRC20 (leucine-rich repeat-containing protein 20) is a 184 amino acid protein that contains 5 LRR (leucine-rich) repeats. Existing as three alternatively spliced isoforms, the gene encoding LRRC20 maps to human chromosome 10. Spanning nearly 135 million base pairs, chromosome 10 makes up approximately 4.5% of total DNA in cells and encodes nearly 1,200 genes. Several protein-coding genes, including those that encode for chemokines, cadherins, excision repair proteins, early growth response factors (Egrs) and fibroblast growth receptors (FGFRs), are located on chromosome 10. Defects in some of the genes that map to chromosome 10 are associated with Charcot-Marie-Tooth disease, Jackson-Weiss syndrome, Usher syndrome, nonsyndromatic deafness, Wolman's syndrome, Cowden syndrome, multiple endocrine neoplasia type 2 and porphyria.

CHROMOSOMAL LOCATION

Genetic locus: LRRC20 (human) mapping to 10q22.1.

SOURCE

LRRC20 (S-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of LRRC20 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-243337 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

RESEARCH USE

For research use only, not for use in diagnostic procedures.

APPLICATIONS

LRRC20 (S-15) is recommended for detection of LRRC20 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other LRRC family members.

LRRC20 (S-15) is also recommended for detection of LRRC20 in additional species, including equine, canine and porcine.

Suitable for use as control antibody for LRRC20 siRNA (h): sc-90571, LRRC20 shRNA Plasmid (h): sc-90571-SH and LRRC20 shRNA (h) Lentiviral Particles: sc-90571-V.
