ANKRD56 (C-17): sc-244967



The Power to Question

BACKGROUND

Ankyrins are membrane adaptor molecules that play important roles in coupling integral membrane proteins to the spectrin-based cytoskeleton network. Mutations of ankyrin genes lead to severe genetic diseases, such as fatal cardiac arrhythmias and hereditary spherocytosis. ANKRD56 (ankyrin repeat domain 56) is a 793 amino acid protein that contains 2 ANK repeats. Conserved in bovine, mouse, rat and chicken, ANKRD56 is encoded by a gene that maps to human chromosome 4, which represents approximately 6% of the human genome and contains nearly 900 genes. Notably, the Huntingtin gene, which encodes an expanded glutamine tract in cases of Huntington's disease, is located on chromosome 4. FGFR-3 is also encoded by a gene that maps to human chromosome 4 and is associated with thanatophoric dwarfism, achondroplasia, Muenke syndrome and bladder cancer. Chromosome 4 is also linked to Ellis-van Creveld syndrome, methylmalonic acidemia and polycystic kidney disease.

Genetic locus: SOWAHB (human) mapping to 4q21.1.

SOURCE

ANKRD56 (C-17) is an affinity purified goat polyclonal antibody raised against a peptide mapping at the C-terminus of ANKRD56 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-244967 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

ANKRD56 (C-17) is recommended for detection of ANKRD56 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other ANKRD family members.

ANKRD56 (C-17) is also recommended for detection of ANKRD56 in additional species, including canine and porcine.

Suitable for use as control antibody for ANKRD56 siRNA (h): sc-89009, ANKRD56 shRNA Plasmid (h): sc-89009-SH and ANKRD56 shRNA (h) Lentiviral Particles: sc-89009-V.
