BACKGROUND

Encoding more than 700 genes, chromosome 15 is made up of approximately 106 million base pairs and is about 3% of the human genome. Angelman and Prader-Willi syndromes are associated with loss of function or deletion of genes in the 15q11-q13 region. In the case of Angelman syndrome, this loss is due to inactivity of the maternal 15q11-q13 encoded UBE3A gene in the brain by either chromosomal deletion or mutation. In cases of Prader-Willi syndrome, there is a partial or complete deletion of this region from the paternal copy of chromosome 15. Tay-Sachs disease is a lethal disorder associated with mutations of the HEXA gene, which is encoded by chromosome 15. Marfan syndrome is associated with chromosome 15 through the FBN1 gene. The FAM154B gene product has been provisionally designated FAM154B pending further characterization.

Genetic locus: FAM154B (human) mapping to 15q25.2.

SOURCE

FAM154B (G-17) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of FAM154B of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-246588 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FAM154B (G-17) is recommended for detection of FAM154B of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with FAM154A.

Suitable for use as control antibody for FAM154B siRNA (h): sc-90085, FAM154B shRNA Plasmid (h): sc-90085-SH and FAM154B shRNA (h) Lentiviral Particles: sc-90085-V.
