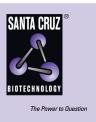

BACKGROUND

Encoding more than 700 genes, chromosome 15 is made up of approximately 106 million base pairs and is about 3% of the human genome. Angelman and Prader-Willi syndromes are associated with loss of function or deletion of genes in the 15q11-q13 region. In the case of Angelman syndrome, this loss is due to inactivity of the maternal 15q11-q13 encoded UBE3A gene in the brain by either chromosomal deletion or mutation. In cases of Prader-Willi syndrome, there is a partial or complete deletion of this region from the paternal copy of chromosome 15. Tay-Sachs disease is a lethal disorder associated with mutations of the HEXA gene, which is encoded by chromosome 15. Marfan syndrome is associated with chromosome 15 through the FBN1 gene. The FLJ38596 gene product has been provisionally designated FLJ38596 pending further characterization.

CHROMOSOMAL LOCATION

Genetic locus: C15orf56 (human) mapping to 15q15.1.

SOURCE

FLJ38596 (P-18) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of FLJ38596 of human origin.

STORAGE

Store at 4° C, **D0 NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-246881 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FLJ38596 (P-18) is recommended for detection of FLJ38596 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Suitable for use as control antibody for FLJ38596 siRNA (h): sc-90022, FLJ38596 shRNA Plasmid (h): sc-90022-SH and FLJ38596 shRNA (h) Lentiviral Particles: sc-90022-V.

Molecular Weight of FLJ38596: 17 kDa.
