LEUTX (C-20): sc-247442



The Power to Question

BACKGROUND

LEUTX (leucine twenty homeobox) is a 168 amino acid nuclear protein that belongs to the paired homeobox family and contains one homeobox DNA-binding domain. The gene encoding LEUTX maps to human chromosome 19, which consists of around 63 million bases with over 1,400 genes, chromosome 19 makes up over 2% of human genomic DNA. Chromosome 19 includes a diversity of interesting genes and is recognized for having the greatest gene density of the human chromosomes. It is the genetic home for a number of immunoglobulin superfamily members including the killer cell and leukocyte lg-like receptors, a number of ICAMs, the CEACAM and PSG families, and Fc α receptors. Key genes for eye color and hair color also map to chromosome 19. Peutz-Jeghers syndrome, spinocerebellar ataxia type 6, the stroke disorder CADASIL, hypercholesterolemia and Insulin-dependent diabetes have been linked to chromosome 19. Translocations with chromosome 19 and chromosome 14 can be seen in some lymphoproliferative disorders and typically involve the proto-oncogene BCL3.

CHROMOSOMAL LOCATION

Genetic locus: LEUTX (human) mapping to 19q13.2.

SOURCE

LEUTX (C-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of LEUTX of human origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-247442 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

Available as TransCruz reagent for Gel Supershift and ChIP applications, sc-247442 X, 200 $\mu g/0.1$ ml.

APPLICATIONS

LEUTX (C-20) is recommended for detection of LEUTX of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

LEUTX (C-20) X TransCruz antibody is recommended for Gel Supershift and ChIP applications.

Molecular Weight of LEUTX: 19 kDa.

RECOMMENDED SECONDARY REAGENTS

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.
