RNF157 (P-18): sc-248460



The Power to Question

BACKGROUND

The RING-type zinc finger motif is present in a number of viral and eukaryotic proteins and is made of a conserved cysteine-rich domain that is able to bind two zinc atoms. Proteins that contain this conserved domain are generally involved in the ubiquitination pathway of protein degradation. RNF157 (RING finger protein 157) is a 679 amino acid protein that contains one RING-type zinc finger and exists as 2 alternatively spliced isoforms. The gene encoding RNF157 maps to human chromosome 17, which comprises over 2.5% of the human genome and encodes over 1,200 genes. Two key tumor suppressor genes are associated with chromosome 17, namely, p53 and BRCA1. Malfunction or loss of p53 expression is associated with malignant cell growth and Li-Fraumeni syndrome. Like p53, BRCA1 is directly involved in DNA repair, and is liked to predisposition of cancers of the ovary, colon, prostate gland and fallopian tubes.

CHROMOSOMAL LOCATION

Genetic locus: RNF157 (human) mapping to 17q25.1; Rnf157 (mouse) mapping to 11 E2.

SOURCE

RNF157 (P-18) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an internal region of RNF157 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-248460 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

RNF157 (P-18) is recommended for detection of RNF157 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with other RNF family members.

RNF157 (P-18) is also recommended for detection of RNF157 in additional species, including equine, canine, bovine, porcine and avian.

Suitable for use as control antibody for RNF157 siRNA (h): sc-94230, RNF157 shRNA Plasmid (h): sc-94230-SH and RNF157 shRNA (h) Lentiviral Particles: sc-94230-V.

Molecular Weight of RNF157 isoforms: 74/71 kDa.
