ZNF805 (E-15): sc-249813



The Power to Question

BACKGROUND

Zinc-finger proteins contain DNA-binding domains and have a wide variety of functions, most of which encompass some form of transcriptional activation or repression. The majority of zinc-finger proteins contain a Krüppel-type DNA binding domain and a KRAB domain, which is thought to interact with KAP1, thereby recruiting histone modifying proteins. ZNF805 (zinc finger protein 805) is a 627 amino acid nuclear protein that may be involved in transcriptional regulation. Belonging to the Krüppel C₂H₂-type zinc-finger protein family, ZNF805 contains 13 C₂H₂-type zinc fingers and a KRAB domain. Existing as two alternatively spliced isoforms, the gene encoding ZNF805 maps to human chromosome 19, which consists of over 63 million bases, houses approximately 1,400 genes and is recognized for having the greatest gene density of the human chromosomes. It is the genetic home for a number of immunoglobulin (Ig) superfamily members, including the killer cell and leukocyte Ig-like receptors, a number of ICAMs, the CEACAM and PSG families, and Fc receptors (FcRs).

CHROMOSOMAL LOCATION

Genetic locus: ZNF805 (human) mapping to 19q13.43.

SOURCE

ZNF805 (E-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of ZNF805 of human origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-249813 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

ZNF805 (E-15) is recommended for detection of ZNF805 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Suitable for use as control antibody for ZNF805 siRNA (h): sc-97473, ZNF805 shRNA Plasmid (h): sc-97473-SH and ZNF805 shRNA (h) Lentiviral Particles: sc-97473-V.

Molecular Weight of ZNF805 isoforms 1/2: 71/57 kDa.
