# CD30 (S-20): sc-25224



The Power to Question

#### **BACKGROUND**

The tumor necrosis factor (TNF) receptor family is composed of several type I integral membrane glycoproteins that exhibit homology in their cystine-rich extracellular domains. Members of this family include FAS, OX40, CD27 and CD30. Ligands for these receptors are often type II transmembrane glycoproteins, as is the case for CD27 and CD30. CD27 homodimeric lymphocyte-specific surface antigen present on T and B lymphocytes. Activation of the CD3 complex via the T cell receptor for antigen leads to an increase in CD27 expression. Together, CD27 and its ligand, CD27L, generate co-stimulatory signals required for complete T cell activation. CD30 is a surface marker for neoplastic cells of the Hodgkin's lymphoma and related hematologic malignancies. CD30L has been shown to enhance the proliferation of the Hodgkin's cell line HDLM-2, but exerts antiproliferative effects on large cell anaplastic lymphoma cell lines.

# SOURCE

CD30 (S-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an extracellular domain of CD30 of mouse origin.

#### **PRODUCT**

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-25224 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

#### **RESEARCH USE**

For research use only, not for use in diagnostic procedures.

#### **APPLICATIONS**

CD30 (S-20) is recommended for detection of CD30 of mouse origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with CD30 short form.

Suitable for use as control antibody for CD30 siRNA (m): sc-37244, CD30 shRNA Plasmid (m): sc-37244-SH and CD30 shRNA (m) Lentiviral Particles: sc-37244-V.

Molecular Weight of CD30: 120 kDa.

Positive Controls: BW5147 cell lysate: sc-3800.
