### 2. Composition, Information or Ingredients

### 3. Hazard Identification

Irritant

Avoid prolonged exposure.

Do Not breathe vapor.

### 4. First Aid Measures

### 6. Accidental Release Measure

**Steps to be taken if material is spilled or otherwise released into the environment:** Wear appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves.
