#### **BACKGROUND**

Santa Cruz Biotechnology's secondary antibodies are available conjugated to either an enzyme, biotin or fluorophore for use in a variety of antibody-based applications including Western Blot, immunostaining, flow cytometry and ELISA. Secondary antibodies are commonly affinity purified against immobilized whole  $\lg G$  isotypes, including  $\lg G_1$ ,  $\lg G_{2a}$ ,  $\lg G_{2b}$ ,  $\lg G_3$  and  $\lg G_4$ . Santa Cruz Biotechnology offers a wide selection of secondary antibodies, which are used in conjunction with our Cruz Marker<sup>TM</sup> molecular weight standards. We also provide specialized secondaries, such as pre-adsorbed secondary antibodies, which are pre-adsorbed with human  $\lg G$  and mouse  $\lg G$  for immunoglobulin-rich tissues and cells,  $\digamma G$  fragment secondary antibodies that reduce non-specific secondary antibody binding to  $\digamma G$  receptors on the cell surface, and isotype-specific secondary antibodies against  $\lg M$ ,  $\lg A$  and  $\lg Y$ .

rabbit anti-goat IgG-HRP is an affinity purified secondary antibody raised in rabbit against goat IgG and conjugated to HRP (horseradish peroxidase).

#### **PRODUCT**

Each vial contains 200 µg lgG in 0.5 ml of 1X PBS containing 40% glycerol.

#### **APPLICATIONS**

rabbit anti-goat IgG-HRP is recommended for detection of goat IgG by Western Blotting (starting dilution: 1:5000, dilution range 1:5000-1:10000; optimal dilution to be determined by titration).


