# Chibby (FL-126): sc-292137



The Power to Question

#### **BACKGROUND**

Chibby, also known as cytosolic leucine-rich protein and PIGEA-14, is a 126 amino acid highly conserved protein that inhibits  $\beta$ -catenin-mediated trancriptional activation by competing with LEF-1 to bind  $\beta$ -catenin. Chibby may also play a role in the regulation of the intracellular location of Polycystin-2 and other intracellular proteins. Acting as a homodimer, Chibby is subcellularly localized to the nucleus and Golgi apparatus within the  $\it trans$ -Golgi network. Interaction with 14-3-3 results in the sequestration of Chibby to the cytoplasm and formation of a stable complex with  $\beta$ -catenin, thereby facilitating nuclear export of  $\beta$ -catenin. Though widely expressed, Chibby is found at highest levels in skeletal muscle, heart, placenta and kidney. Downregulation of Chibby is observed in thyroid and metastatic uterine tumors, suggesting that the gene encoding Chibby may function as a tumor suppressor.

Genetic locus: CBY1 (human) mapping to 22q13.1; Cby1 (mouse) mapping to 15 E1.

## SOURCE

Chibby (FL-126) is a rabbit polyclonal antibody raised against amino acids 1-126 representing full length Chibby of human origin.

## **PRODUCT**

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

#### **APPLICATIONS**

Chibby (FL-126) is recommended for detection of Chibby of human and, to a lesser extent, mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunoprecipitation [1-2  $\mu$ g per 100-500  $\mu$ g of total protein (1 ml of cell lysate)], immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Chibby (FL-126) is also recommended for detection of Chibby in additional species, including equine, canine, bovine and porcine.

Suitable for use as control antibody for Chibby siRNA (h): sc-72890, Chibby siRNA (m): sc-142327, Chibby shRNA Plasmid (h): sc-72890-SH, Chibby shRNA Plasmid (m): sc-142327-SH, Chibby shRNA (h) Lentiviral Particles: sc-72890-V and Chibby shRNA (m) Lentiviral Particles: sc-142327-V.
