Manic Fringe (M-56): sc-292668



BACKGROUND

Three mammalian fringe family members, Manic, Radical and Lunatic Fringe, have been identified as proteins related to *Drosophila* fringe, a protein involved in development. Fringe proteins act upstream of the Notch signaling pathway and are involved in boundary determination during segmentation. Each mammalian fringe displays different patterns of expression, though all are expressed in the mouse embryo as well as in many adult tissues. Radical fringe plays a key role in the development of the limb bud. Lunatic fringe is required for normal somite segmentation and patterning and is thought to be a target of the molecular clock. Manic fringe, also involved in somatic development, has been shown to render mouse NIH/3T3 cells tumorigenic in SCID mice.

Genetic locus: Mfng (mouse) mapping to 15 E1.

SOURCE

Manic Fringe (M-56) is a rabbit polyclonal antibody raised against amino acids 1-56 mapping at the N-terminus of Manic Fringe of mouse origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

For research use only, not for use in diagnostic procedures.

APPLICATIONS


Manic Fringe (M-56) is recommended for detection of Manic Fringe of mouse and rat origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunoprecipitation [1-2 μ g per 100-500 μ g of total protein (1 ml of cell lysate)], immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Suitable for use as control antibody for Manic Fringe siRNA (m): sc-39493, Manic Fringe shRNA Plasmid (m): sc-39493-SH and Manic Fringe shRNA (m) Lentiviral Particles: sc-39493-V.

Positive Controls: mouse kidney extract: sc-2255, mouse skin extract: sc-364251 or WEHI-231 whole cell lysate: sc-2213.

RECOMMENDED SECONDARY REAGENTS

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use goat anti-rabbit IgG-HRP: sc-2004 (dilution range: 1:2000-1:100,000) or Cruz Marker[™] compatible goat anti-rabbit IgG-HRP: sc-2030 (dilution range: 1:2000-1:5000), Cruz Marker[™] Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunoprecipitation: use Protein A/G PLUS-Agarose: sc-2003 (0.5 ml agarose/2.0 ml). 3) Immunofluorescence: use goat anti-rabbit IgG-FITC: sc-2012 (dilution range: 1:100-1:400) or goat anti-rabbit IgG-TR: sc-2780 (dilution range: 1:100-1:400) with UltraCruz[™] Mounting Medium: sc-24941.
