ZNF616 (N-15): sc-324695



The Power to Question

BACKGROUND

Zinc-finger proteins contain DNA-binding domains and have a wide variety of functions, most of which encompass some form of transcriptional activation or repression. The majority of zinc-finger proteins contain a krüppel-type DNA binding domain and a KRAB domain, which is thought to interact with KAP1, thereby recruiting histone modifying proteins. ZNF616 (zinc finger protein 616) is a 781 amino acid nuclear protein that may be involved in transcriptional regulation. Belonging to the krüppel C_2H_2 -type zinc-finger protein family, ZNF616 contains 21 C_2H_2 -type zinc fingers and one KRAB domain. The gene encoding ZNF616 maps to human chromosome 19q13.41. Chromosome 19 consists of over 63 million bases, houses approximately 1,400 genes and is recognized for having the greatest gene density of the human chromosomes. It is the genetic home for a number of immunoglobulin (Ig) superfamily members, including the killer cell and leukocyte Ig-like receptors, a number of ICAMs, the CEACAM and PSG families, and Fc receptors (FcRs).

Genetic locus: ZNF616 (human) mapping to 19q13.41.

SOURCE

ZNF616 (N-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of ZNF616 of human origin.

STORAGE

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-324695 P, ($100 \mu g$ peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

ZNF616 (N-15) is recommended for detection of ZNF616 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); may cross-react with ZNF841.

Suitable for use as control antibody for ZNF616 siRNA (h): sc-97323, ZNF616 shRNA Plasmid (h): sc-97323-SH and ZNF616 shRNA (h) Lentiviral Particles: sc-97323-V.

Molecular Weight of ZNF616: 90 kDa.
