# FOXI3 (S-17): sc-324863



The Power to Question

#### **BACKGROUND**

The forkhead-box (FOX) genes comprise a superfamily of at least 43 members that encode proteins which are involved in transcriptional regulation and may be associated with the pathogenesis of various cancers. FOXI3 (forkhead box I3) is a member of the FOX family which contains one forkhead DNA-binding domain. FOXI3 localizes to the nucleus where it is thought to function as a transcription factor that can bind to DNA via the forkhead domain. The gene that encodes FOXI3 maps to human chromosome 2, the second largest human chromosome consisting of 237 million bases encoding over 1,400 genes. A number of genetic diseases are linked to genes on chromosome 2. Harlequin icthyosis, a rare and morbid skin deformity, is associated with mutations in the ABCA12 gene. The lipid metabolic disorder sitosterolemia is associated with ABCG5 and ABCG8. An extremely rare recessive genetic disorder, Alström syndrome, is due to mutations in the ALMS1 gene.

Genetic locus: FOXI3 (human) mapping to 2p11.2.

# SOURCE

FOXI3 (S-17) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of FOXI3 of human origin.

#### **PRODUCT**

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-324863 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

Available as TransCruz reagent for Gel Supershift and ChIP applications, sc-324863 X, 200  $\mu$ g/0.1 ml.

#### **APPLICATIONS**

FOXI3 (S-17) is recommended for detection of FOXI3 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with FOXI1 or FOXI2.

FOXI3 (S-17) is also recommended for detection of FOXI3 in additional species, including canine and porcine.

Suitable for use as control antibody for FOXI3 siRNA (h): sc-94550, FOXI3 shRNA Plasmid (h): sc-94550-SH and FOXI3 shRNA (h) Lentiviral Particles: sc-94550-V.

FOXI3 (S-17) X TransCruz antibody is recommended for Gel Supershift and ChIP applications.

Molecular Weight of FOXI3: 43 kDa.

Positive Controls: Jurkat whole cell lysate: sc-2204.
