## BACKGROUND

The Clustered Regularly Interspaced Short Palindromic Repeats (CRISPR) and CRISPR-associated protein (Cas9) system is an adaptive immune response defense mechanism used by archea and bacteria for the degradation of foreign genetic material ( 4,6 ). This mechanism can be repurposed for other functions, including genomic engineering for mammalian systems, such as gene knockout (KO) (1,2,3,5). CRISPR/Cas9 K0 Plasmid products enable the identification and cleavage of specific genes by utilizing guide RNA (gRNA) sequences derived from the Genome-scale CRISPR Knock-Out (GeCKO) v2 library developed in the Zhang Laboratory at the Broad Institute $(3,5)$.

## CHROMOSOMAL LOCATION

Genetic locus: SEC24A (human) mapping to 5q31.1.

## PRODUCT

SEC24A CRISPR/Cas9 KO Plasmid (h) is designed to disrupt gene expression by causing a double-strand break (DSB) in a 5 ' constitutive exon within the SEC24A (human) gene.

SEC24A CRISPR/Cas9 K0 Plasmid (h) consists of a pool of 3 plasmids, each encoding the Cas9 nuclease and a target-specific 20 nt guide RNA (gRNA) designed for maximum knockout efficiency. Each vial contains $20 \mu \mathrm{~g}$ of lyophilized CRISPR/Cas9 Plasmid DNA. Suitable for up to 20 transfections. Also see SEC24A HDR Plasmid (h): sc-407059-HDR for selection of cells containing a DSB induced by SEC24A CRISPR/Cas9 KO Plasmid (h).

## STORAGE AND RESUSPENSION

Store lyophilized plasmid DNA at $4^{\circ} \mathrm{C}$ with desiccant. Stable for at least one year from the date of shipment. Once resuspended, store at $4^{\circ} \mathrm{C}$ for short term storage or $-20^{\circ} \mathrm{C}$ for long-term storage. Avoid repeated freeze thaw cycles.
Resuspend lyophilized plasmid DNA in $200 \mu \mathrm{l}$ of the provided ultrapure, sterile, DNase-free water. Resuspension of the plasmid DNA makes a $0.1 \mu \mathrm{~g} / \mu \mathrm{l}$ solution in a 10 mM TRIS EDTA, 1 mM EDTA buffered solution.

## APPLICATIONS

SEC24A CRISPR/Cas9 KO Plasmid (h) is recommended for the disruption of gene expression in human cells.

## SUPPORT REAGENTS

For optimal reaction efficiency with CRISPR/Cas9 K0 Plasmids, Santa Cruz Biotechnology's UltraCruz ${ }^{\circledR}$ Transfection Reagent: sc-395739 ( 0.2 ml ) and Plasmid Transfection Medium: sc-108062 (20 ml) are recommended. Control CRISPR/Cas9 Plasmid: sc-418922 $(20 \mu \mathrm{~g})$ negative control is also available.

## GENE EXPRESSION MONITORING

SEC24A (4D9): sc-517155 is recommended as a control antibody for monitoring of SEC24A (human) gene expression prior to and after knockout by Western blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).
