HCN3 (P-15): sc-46356



The Power to Question

BACKGROUND

Hyperpolarization-activated, cyclic nucleotide-binding channels (HCN) are voltage-gated cation channels that are activated by direct binding of intracellular cyclic nucleotides. The HCN family consists of four members (HCN1-4), each with a core transmembrane segment domain and a C-terminal 120 amino acid cyclic nucleotide-binding domain motif. HCN channels are expressed in the brain, heart, thalamus and testis. The pacemaker properties of HCN channels contribute to spontaneous rhythmic activity in the brain and heart. HCN3 contains a segment characterized by a series of positively charged amino acids at every third position. This region designated S4 is likely to be the voltage sensor of the protein. In the brain, HCN3 and HCN4 exhibit subcortical distribution mainly concentrated in the hypothalamus and thalamus, respectively.

CHROMOSOMAL LOCATION

Genetic locus: HCN3 (human) mapping to 1q22; Hcn3 (mouse) mapping to 3 F1.

SOURCE

HCN3 (P-15) is an affinity purified goat polyclonal antibody raised against a peptide mapping within a C-terminal cytoplasmic domain of HCN3 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-46356 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

STORAGE

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

APPLICATIONS

HCN3 (P-15) is recommended for detection of HCN3 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

HCN3 (P-15) is also recommended for detection of HCN3 in additional species, including equine, canine, bovine and porcine.

Suitable for use as control antibody for HCN3 siRNA (h): sc-45651, HCN3 siRNA (m): sc-45652, HCN3 shRNA Plasmid (h): sc-45651-SH, HCN3 shRNA Plasmid (m): sc-45652-SH, HCN3 shRNA (h) Lentiviral Particles: sc-45651-V and HCN3 shRNA (m) Lentiviral Particles: sc-45652-V.
