The Power to Question

BACKGROUND

Xylosyltransferase-I (XyIT-I), also designated UDP-D-xylose:proteoglycan core protein $\beta\text{-}D\text{-}xylosyltransferase 1, is a glycoprotein that catalyzes the transfer of UDP-xylose to serine residues within XT recognition sequences of target proteins. Addition of xylose to the core protein is a requirement for the biosynthesis of the glycosaminoglycan chains that are characteristic of proteoglycans. Xylosyltransferase proteins, which can be secreted, display activity in sternal cartilage chondrocytes, chondrosarcoma, nasal septum tumor and choriocarcinoma cells. XYIT-I is widely expressed, with higher levels of expression detected in placenta, kidney and pancreas, and lower levels of expression observed in skeletal muscle. Xylosyltrans-ferase-II (XyIT-II), also designated UDP-D-xylose:proteoglycan core protein <math display="inline">\beta\text{-}D\text{-}xylosyltransferase 2$, is also widely expressed, with higher levels of expression detected in kidney and pancreas.

CHROMOSOMAL LOCATION

Genetic locus: XYLT1 (human) mapping to 16p12.3; Xylt1 (mouse) mapping to 7 F2.

SOURCE

XyIT-I (C-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of XyIT-I of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-50871 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

STORAGE

Store at 4° C, **DO NOT FREEZE**. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

APPLICATIONS

XyIT-I (C-20) is recommended for detection of XyIT-I of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunoprecipitation [1-2 μg per 100-500 μg of total protein (1 ml of cell lysate)], immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

XyIT-I (C-20) is also recommended for detection of XyIT-I in additional species, including equine, canine, bovine and porcine.

Suitable for use as control antibody for XyIT-I siRNA (h): sc-61817, XyIT-I siRNA (m): sc-61818, XyIT-I shRNA Plasmid (h): sc-61817-SH, XyIT-I shRNA Plasmid (m): sc-61818-SH, XyIT-I shRNA (h) Lentiviral Particles: sc-61817-V and XyIT-I shRNA (m) Lentiviral Particles: sc-61818-V.


