The Boures to Overtion

BACKGROUND

F-box only protein 8 (FBX08) is a 319 amino acid protein encoded by the human gene FBX08. FBX08 contains one 40 amino acid F-box region making it a member of the F-box family. FBX08 also contains one SEC7 domain, a domain that catalyzes exchange of GDP for GTP on the ARF family of small GTP-binding proteins. F-box proteins are critical components of the SCF (Skp1-CUL-1-F-box protein)-type E3 ubiquitin ligase complex and are involved in substrate recognition and recruitment for ubiquitination. F-box proteins are members of a large family that regulates cell cycle, immune response, signalling cascades and developmental programs by targeting proteins, such as cyclins, cyclin-dependent kinase inhibitors, $l_{\rm K}B\alpha$ and β -catenin, for degradation by the proteasome after ubiquitination. Localized near the nucleus in the cytoplasm, FBX08 is ubiquitously expressed and believed to promote the activation of ARF through replacement of GDP with GTP.

Genetic locus: FBX08 (human) mapping to 4q34.1; Fbxo8 (mouse) mapping to 8 B2.

SOURCE

FBX08 (C-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of FBX08 of human origin.

RESEARCH USE

For research use only, not for use in diagnostic procedures.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-67630 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

FBX08 (C-20) is recommended for detection of FBX08 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunoprecipitation [1-2 μ g per 100-500 μ g of total protein (1 ml of cell lysate)], immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

FBX08 (C-20) is also recommended for detection of FBX08 in additional species, including equine, canine, bovine, porcine and avian.
