CSMD3 (Y-19): sc-68284



The Power to Question

BACKGROUND

The CUB and sushi domain-containing proteins, CSMD1-3, are membrane proteins that are involved in cell-cell adhesion and are weakly expressed in most tissues, with higher levels of expression observed in the cerebellum and hippocampus. CSMD1 is part of the complement system that defends against pathogens through either the classical pathway or the alternative pathway. Located primarily in nerve growth cones, CSMD1 blocks the classical pathway of the immune system and is thought to be involved in tumor suppression, as defects in the gene encoding CSMD1 are associated with squamous cell carcinomas. CSMD2 and CSMD3 are located primarily in the brain and are implicated in some forms of head and neck cancer. Additionally, the CSMD3 gene is a candidate for induction of epileptic seizures.

CHROMOSOMAL LOCATION

Genetic locus: CSMD3 (human) mapping to 8q23.3; Csmd3 (mouse) mapping to 15 B3.3.

SOURCE

CSMD3 (Y-19) is an affinity purified goat polyclonal antibody raised against a peptide mapping within an extracellular domain of CSMD3 of human origin.

PRODUCT

Each vial contains 200 μg lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-68284 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

CSMD3 (Y-19) is recommended for detection of CSMD3 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

CSMD3 (Y-19) is also recommended for detection of CSMD3 in additional species, including equine, canine, porcine and avian.

Suitable for use as control antibody for CSMD3 siRNA (h): sc-77038, CSMD3 siRNA (m): sc-77039, CSMD3 shRNA Plasmid (h): sc-77038-SH, CSMD3 shRNA Plasmid (m): sc-77039-SH, CSMD3 shRNA (h) Lentiviral Particles: sc-77038-V and CSMD3 shRNA (m) Lentiviral Particles: sc-77039-V.
