# Xinβ (C-20): sc-83127



The Power to Question

# **BACKGROUND**

Xin $\beta$ , also known as CMYA3 (cardiomyopathy-associated protein 3) or XIRP2 (Xin Actin-binding repeat containing 2), is a 3,374 amino acid protein that co-localizes with Actin stress fibers at the cell junction and contains 28 Xin repeats. Interacting with with F-Actin and  $\alpha$ -actinin-2, Xin $\beta$  functions to protect Actin filaments from depolymerization, thereby playing an important role in Actin organization and structural maintenance. Multiple isoforms of Xin $\beta$  exist due to alternative splicing events. The gene encoding Xin $\beta$  maps to human chromosome 2, which houses over 1,400 genes and comprises nearly 8% of the human genome. Harlequin icthyosis, a rare and morbid skin deformity, is associated with mutations in the ABCA12 gene, while the lipid metabolic disorder sitosterolemia is associated with defects in the ABCG5 and ABCG8 genes. Additionally, an extremely rare recessive genetic disorder, Alström syndrome, is caused by mutations in the ALMS1 gene, which maps to chromosome 2.

Genetic locus: XIRP2 (human) mapping to 2q24.3; Xirp2 (mouse) mapping to 2  $\rm C1.3$ .

# **SOURCE**

 $Xin\beta$  (C-20) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the C-terminus of  $Xin\beta$  of human origin.

## **STORAGE**

Store at 4° C, \*\*D0 NOT FREEZE\*\*. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

#### **PRODUCT**

Each vial contains 200  $\mu g$  lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-83127 P, (100  $\mu$ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

# **APPLICATIONS**

Xinβ (C-20) is recommended for detection of Xinβ of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

 $Xin\beta$  (C-20) is also recommended for detection of  $Xin\beta$  in additional species, including equine, bovine and porcine.

Suitable for use as control antibody for Xin $\beta$  siRNA (h): sc-72933, Xin $\beta$  siRNA (m): sc-72934, Xin $\beta$  shRNA Plasmid (h): sc-72933-SH, Xin $\beta$  shRNA Plasmid (m): sc-72934-SH, Xin $\beta$  shRNA (h) Lentiviral Particles: sc-72933-V and Xin $\beta$  shRNA (m) Lentiviral Particles: sc-72934-V.

 $Xin\beta$  (C-20) X TransCruz antibody is recommended for Gel Supershift and ChIP applications.
