# RRP7A (S-14): sc-86109



The Power to Question

#### **BACKGROUND**

CGI-96, also known as RRP7A (ribosomal RNA processing 7 homolog A), is a 280 amino acid protein that contains one RRM domain and is encoded by a gene which maps to human chromosome 22. Mutations in several of the genes that map to chromosome 22 are involved in the development of Phelan-McDermid syndrome, Neurofibromatosis type 2, autism and schizophrenia. Additionally, translocations between chromosomes 9 and 22 may lead to the formation of the Philadelphia Chromosome and the subsequent production of the novel fusion protein BCR-Abl, a potent cell proliferation activator found in several types of leukemias.

Genetic locus: RRP7A (human) mapping to 22q13.2; Rrp7a (mouse) mapping to 15 E1.

#### **SOURCE**

RRP7A (S-14) is an affinity purified rabbit polyclonal antibody raised against a peptide mapping within an internal region of RRP7A of human origin.

# **PRODUCT**

Each vial contains 100  $\mu g$  lgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-86109 P, (100 μg peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

# **STORAGE**

Store at 4° C, \*\*DO NOT FREEZE\*\*. Stable for one year from the date of shipment. Non-hazardous. No MSDS required.

#### **APPLICATIONS**

RRP7A (S-14) is recommended for detection of RRP7A of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunoprecipitation [1-2 µg per 100-500 µg of total protein (1 ml of cell lysate)], immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).
