BACKGROUND

Members of the bactericidal/permeability-increasing protein family have antimicrobial properties and bind lipophilic substances, therefore targeting gramnegative bacteria. The bactericidal permeability increasing protein (BPI) is an antibacterial and endotoxin-neutralizing molecule that is abundant in the granules of polymorphonuclear leukocytes (neutrophil granules). Sharing structural and sequence homologies with BPI, BPIL1 (bactericidal/permeability-increasing protein-like 2) is a 507 amino acid secreted protein that contains the family's common conserved feature of 2 cysteine residues that are critical for protein function. While BPIL2 is expressed in the basal layer of inflamed epidermis from psoriasis patients, it is not detected in normal skin.

CHROMOSOMAL LOCATION

Genetic locus: BPIFC (human) mapping to 22q12.3; Bpifc (mouse) mapping to 10 C1.

SOURCE

BPIL2 (N-12) is an affinity purified goat polyclonal antibody raised against a peptide mapping near the N-terminus of BPIL2 of human origin.

PRODUCT

Each vial contains 200 μg IgG in 1.0 ml of PBS with <0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-86308 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

BPIL2 (N-12) is recommended for detection of BPIL2 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000); non cross-reactive with BPIL1 and BPIL3.

BPIL2 (N-12) is also recommended for detection of BPIL2 in additional species, including equine and porcine.

Suitable for use as control antibody for BPIL2 siRNA (h): sc-72659, BPIL2 siRNA (m): sc-141732, BPIL2 shRNA Plasmid (h): sc-72659-SH, BPIL2 shRNA Plasmid (m): sc-141732-SH, BPIL2 shRNA (h) Lentiviral Particles: sc-72659-V and BPIL2 shRNA (m) Lentiviral Particles: sc-141732-V.
