BACKGROUND

Chromosome 22 contains over 500 genes and about 49 million bases. Being the second smallest human chromosome, 22 contains a surprising variety of interesting genes. Phelan-McDermid syndrome, neurofibromatosis type 2 and autism are associated with chromosome 22. A schizophrenia susceptibility locus has been identified on chromosome 22 and studies show that 22q11 deletion symptoms include a high incidence of schizophrenia. Translocations between chromosomes 9 and 22 may lead to the formation of the philadelphia chromosome and the subsequent production of the novel fusion protein, BCR-AbI, a potent cell proliferation activator found in several types of leukemia. The LOC646851 gene product has been provisionally designated LOC646851 pending further characterization.

Genetic locus: LOC646851 (human) mapping to 22q13.1.

SOURCE

LOC646851 (L-16) is an affinity purified rabbit polyclonal antibody raised against a peptide mapping within an internal region of LOC646851 of human origin.

PRODUCT

Each vial contains 100 μg IgG in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-86609 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

LOC646851 (L-16) is recommended for detection of LOC646851 of human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

Suitable for use as control antibody for LOC646851 siRNA (h): sc-75539, LOC646851 shRNA Plasmid (h): sc-75539-SH and LOC646851 shRNA (h) Lentiviral Particles: sc-75539-V.
