TMEM64 (C-15): sc-87460



The Power to Question

BACKGROUND

TMEM64 (transmembrane protein 64) is a 119 amino acid protein encoded by a gene mapping to human chromosome 8. Made up of nearly 146 million bases, chromosome 8 encodes about 800 genes. Translocation of portions of chromosome 8 with amplifications of the c-Myc gene are found in some leukemias and lymphomas, and typically associated with a poor prognosis. Portions of chromosome 8 have been linked to schizophrenia and bipolar disorder. Trisomy 8, also known as Warkany syndrome 2, most often results in early miscarriage but is occasionally seen in a mosaic form in surviving patients who suffer to a varying degree from a number of symptoms including retarded mental and motor development, and certain facial and developmental defects. WRN is a DNA helicase encoded by chromosome 8 and shown defective in those with the early aging disorder Werner syndrome. Chromosome 8 is also associated with Pfeiffer syndrome, congenital hypothyroidism and Waardenburg syndrome.

CHROMOSOMAL LOCATION

Genetic locus: TMEM64 (human) mapping to 8q21.3; Tmem64 (mouse) mapping to 4 A2.

SOURCE

TMEM64 (C-15) is an affinity purified rabbit polyclonal antibody raised against a peptide mapping near the C-terminus of TMEM64 of human origin.

PRODUCT

Each vial contains 100 μg IgM in 1.0 ml of PBS with < 0.1% sodium azide and 0.1% gelatin.

Blocking peptide available for competition studies, sc-87460 P, (100 μ g peptide in 0.5 ml PBS containing < 0.1% sodium azide and 0.2% BSA).

APPLICATIONS

TMEM64 (C-15) is recommended for detection of TMEM64 of mouse, rat and human origin by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000), immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500) and solid phase ELISA (starting dilution 1:30, dilution range 1:30-1:3000).

TMEM64 (C-15) is also recommended for detection of TMEM64 in additional species, including equine and bovine.

Suitable for use as control antibody for TMEM64 siRNA (h): sc-77785, TMEM64 siRNA (m): sc-154490, TMEM64 shRNA Plasmid (h): sc-77785-SH, TMEM64 shRNA Plasmid (m): sc-154490-SH, TMEM64 shRNA (h) Lentiviral Particles: sc-77785-V and TMEM64 shRNA (m) Lentiviral Particles: sc-154490-V.
