The Power to Question

BACKGROUND

The Insulin gene family, comprised of Insulin, relaxin and Insulin-like growth factors I and II (IGF-I and IGF-II), represents a group of structurally related polypeptides whose biological functions have diverged. The IGFs, or somatomedins, constitute a class of polypeptides that have a key role in pre-adolescent mammalian growth. IGFL3 (IGF-like family member 3), also known as UNQ483, is a 125 amino acid secreted protein that belongs to the IGF family and is thought to play a role in energy metabolism and growth and developmental events. Expressed at high levels in brain tissue, IGFL3 contains 2 CC motifs and 11 regularly spaced cysteine residues and is encoded by a gene which maps to an IGFL cluster on chromosome 19q13.32.

CHROMOSOMAL LOCATION

Genetic locus: Igfl3 (mouse) mapping to 7 A2.

PRODUCT

IGFL3 siRNA (m) is a target-specific 19-25 nt siRNA designed to knock down gene expression. Each vial contains 3.3 nmol of lyophilized siRNA, sufficient for a 10 μ M solution once resuspended using protocol below. Suitable for 50-100 transfections. Also see IGFL3 shRNA Plasmid (m): sc-146182-SH and IGFL3 shRNA (m) Lentiviral Particles: sc-146182-V as alternate gene silencing products.

STORAGE AND RESUSPENSION

Store lyophilized siRNA duplex at -20° C with desiccant. Stable for at least one year from the date of shipment. Once resuspended, store at -20° C, avoid contact with RNAses and repeated freeze thaw cycles.

Resuspend lyophilized siRNA duplex in 330 μ l of the RNAse-free water provided. Resuspension of the siRNA duplex in 330 μ l of RNAse-free water makes a 10 μ M solution in a 10 μ M Tris-HCl, pH 8.0, 20 mM NaCl, 1 mM EDTA buffered solution.

APPLICATIONS

 $\operatorname{IGFL3}$ siRNA (m) is recommended for the inhibition of $\operatorname{IGFL3}$ expression in mouse cells.

SUPPORT REAGENTS

For optimal siRNA transfection efficiency, Santa Cruz Biotechnology's siRNA Transfection Reagent: sc-29528 (0.3 ml), siRNA Transfection Medium: sc-36868 (20 ml) and siRNA Dilution Buffer: sc-29527 (1.5 ml) are recommended. Control siRNAs or Fluorescein Conjugated Control siRNAs are available as 10 µM in 66 µl. Each contain a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA. Fluorescein Conjugated Control siRNAs include: sc-36869, sc-44239, sc-44240 and sc-44241. Control siRNAs include: sc-37007, sc-44230, sc-44231, sc-44232, sc-44233, sc-44234, sc-44235, sc-44236, sc-44237 and sc-44238.

RT-PCR REAGENTS

Semi-quantitative RT-PCR may be performed to monitor IGFL3 gene expression knockdown using RT-PCR Primer: IGFL3 (m)-PR: sc-146182-PR (20 μ l). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.
