3. HANDLING AND STORAGE

7. REGULATORY INFORMATION

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Wash thoroughly after handling.

9. FIRST-AID MEASURES

 In cases of INGESTION: If swallowed, rinse mouth out with water, contact local poison centre and call a physician.

10. FIRE-FIGHTING MEASURES

 Unusual Fire and Explosive Hazards: May emit toxic gases upon thermal decomposition.

11. ACCIDENTAL RELEASE MEASURES
