HANDLING AND STORAGE: Keep locked up. Keep away from heat, sources of ignition and incompatibles such as oxidizing agents. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Avoid contact with skin and eyes; do not breathe dust. Avoid prolonged or

repeated exposure. Immediately remove all contaminated clothing. Wash hands before breaks and after work. Avoid eating, drinking and storage of food in the work room. Store tightly sealed at -20 °C.
