4. FIRST AID MEASURES

General advice

If inhaled

6. ACCIDENTAL RELEASE MEASURES

Personal precautions

Methods and materials for containment and cleaning up

Sweep up and shovel. Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations (see section 13). Keep in suitable, closed containers for disposal.

7. HANDLING AND STORAGE

Precautions for safe handling

Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation at places where dust is formed. Keep away from sources of ignition - No smoking.

Conditions for safe storage

Keep container tightly closed in a dry and well-ventilated place. Store under inert gas. Keep in a dry place. Desiccate at room temperature.
