## 4 First aid measures

Jaundice, anemia, and leucocytosis has been reported in some cases. Some are suspected carcinogens, teratogens or mutagens.

**Additional toxicological information:**

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.

No classification data on carcinogenic properties of this material is available from the EPA, IARC, NTP, OSHA or ACGIH.
